FINE SCHEDULE FOR PROPERTY OWNERS ASSOCIATION OF PARK PLACE SUBDIVISION, INC.

WHEREAS, the Association is the property owners' association for Park Place Subdivisions, Sections 1 and 2, (collectively the "Subdivision"); and


WHEREAS, the Subdivision is subject to certain dedications, conditions and restrictions (the "Restrictions") set out in instruments recorded in the Official Public Records of Real Property of Montgomery County, Texas as follows: Clerk's File No. 9404830 and File Code No. 945-01-0390 of the Official Public Records of Real Property of Montgomery County, Texas, and Clerk's File No. 99096827 and Film Code No. 620-00-0002 of the Official Public Records of Real Property of Montgomery County, Texas, respectively; and

WHEREAS, Pursuant to the Restrictions, the Board of Directors of the Association is authorized to adopt, amend, repeal and enforce various rules and regulations, fines, and/or other levies as it deems necessary or desirable with respect to the interpretation and implementation of the Restrictions, the operation of the Association, and the use and enjoyment of any common areas and other property owner controlled by the Association; and

WHEREAS, the Association desires, pursuant to the authority set out in the Restrictions, and as set out in Chapter 204.010 of the Texas Property Code, to adopt a Fine Schedule and to impose, implement and levy fines as set out in the Fine Schedule, and as may be deemed necessary or desirable, as determined by the Board of Directors of the Association, for the interpretation and implementation of the Restrictions, the operation of the Association, and the use and enjoyment of any common areas and other property owner controlled by the Association.

NOW, THEREFORE, for the purpose of adopting a Fine Schedule for the implementation and enforcement of the Restrictions, be it

RESOLVED by the Board of Directors of Property Owners Association of Park Place Subdivision, Inc., that the following Fine Schedule be adopted.



Fine Schedule

Initial Fine for Noncompliance

\$ 250.00

(per instance)

One time fine assessed for all noncompliance issues.

Monthly Fine for Continued Noncompliance

\$ 100.00

(until resolved)

Monthly fines will be assessed based on monthly compliance surveys for each month or partial month until compliance is achieved.

Nothing herein shall be construed to limit the Association's remedies for violation of the Restrictions or other rules and/or regulations, to the levying of the fines only, and the Association shall maintain the right to pursue all suits, actions, claims, or other remedies, as more fully identified in the Restrictions, and/or applicable state law, including, but not limited to, when justified, filing suit in a court of competent jurisdiction seeking mandatory injunctive relief.

The Board of Directors hereby approves and authorizes the Fine Schedule.
